Acceptable Residency Document Groups

Effective 2017, Little League has divided residency documents into three different groups. Players must establish residence eligibility by providing one document from each of the three categories listed below.

Additionally, Little League requires that each of your three residency documents must:

- 1. be dated or in-force between February 1, 2017 and February 1, 2018, and
- 2. all reflect the same address that your player is registered under.

Note: you may block out personal information such as account numbers or financial information, just make sure your name, address and date on the documents are all readable.
